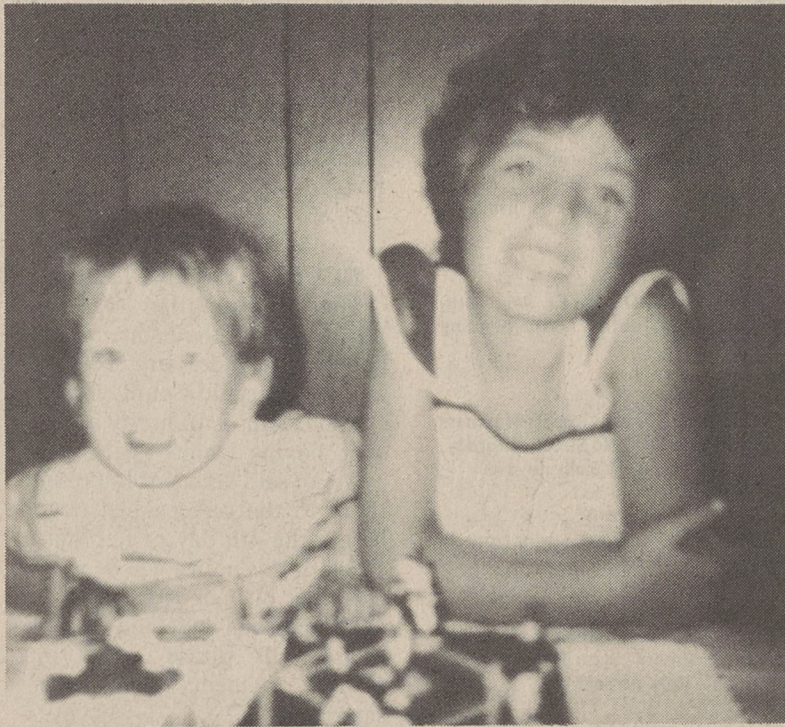


Four Wrecks Reported

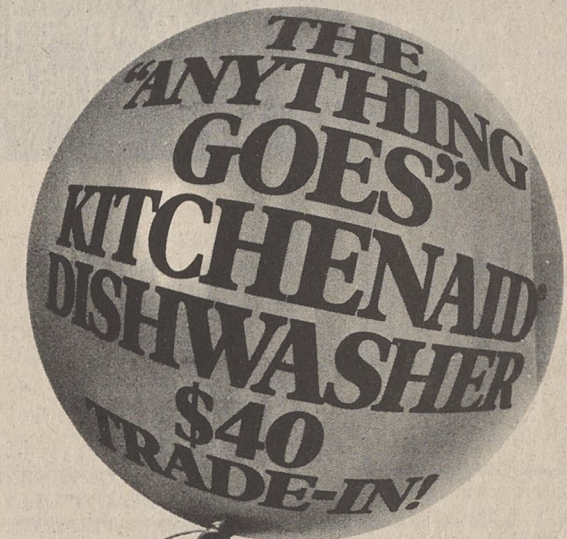

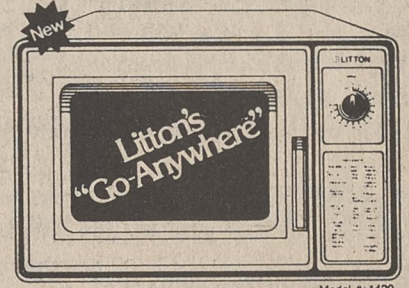

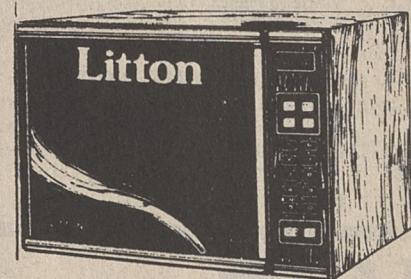
