Stewart Reissues Debate Challenge To Opponents

Former House Speaker Carl J. Stewart, a candidate for the Democratic nomination for Lieutenant Governor, sharply criticized his potential opponents today for refusing to debate him publicly in a series of debates and re-issued the challenge.

Stewart recently sent telegrams to Sen. Harold Hardison of Deep Run and to Sen. Robert Jordan of Mt. Gilead suggesting four one-hour statewide debates in a format determined by the N.C. League of Women Voters.

"I think the people of North Carolina should be offended by the refusal of Sen. Jordan and Sen. Hardison to engage in a public debate on the issues which affect the office of Lieutenant Governor," Stewart said.

"I am particularly appalled by Sen. Jordan's statement that a few Young Democrats forums around the State will provide an adequate airing of the issues. Those meetings cost about \$10 each, have no media coverage, and will be seen by only a few hundred people in the State," said Stewart.

In contrast, Stewart's proposal called for publicly televised debates to take place in four geographic regions with full television and print media coverage. Stewart said that his procedure would give people across the State the opportunity to hear and see the candidates, either in-person or on television.

"I have no explanation for why Sen. Jordan refuses to participate. Apparently, he does not want to be seen with other candidates. To many, his position may seem to indicate a philosophy of representing the wealthy and the exclusive rather than all of the people.

"I hope interested North Carolinians, and especiall members of the League of Women Voters, will write to these two candidates and urge them to accept a debate which in modern times is so essential to intelligent voting," said Stewart.

Stewart suggested that his opponents should reply to the reissuance of his challenge before November 10, so as to allow sufficient time for all arrangements.

Stewart was the first two-term Speaker of the House in over 100 years. He created the first

RALEIGH--Representative Jack Hunt of Cleveland County has been appointed by House Speaker Liston B. Ramsey to a special commission to consider the elimination of some of the 320 boards operating within the Executrix Branch of the State government.
