## Art Exhibit Set At GC

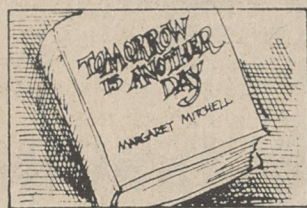
