

## Is There Gold In These Hills?

Is there some gold still in them 'thar hills around Kings Mountain? Many people think maybe there is.

Several companies have been in the area recently getting permission to core drill land in the York Road areas and the old mountain ridge that runs from Kings Mountain to the Broad River in South Carolina.

A new method of drilling doesn't bother the land, so most area residents have given permission to have their land tested. Gold was taken off Kings Mountain land at least once in the past.

There are some old gold mine shafts on the Carl Mauney property off York Road and some on some land that once was owned by my grandfather, John Stewart, in the Dixon Community.

One geologist working the area recently said the gold samples taken out of Kings Creek were purer than gold now being mined in Alaska. Only trouble is, there's not that much of it.

A spokesman for one of the companies checking out the area said last week that his geologists are going to stop work for the next couple of months and analyze the samples they now have to see if it would be profitable to go any further.

Meanwhile, many area residents are being asked to lease their land for gold mining, and some are seriously considering t.

# The Doc's Still In

No, Dr. Joseph Talley hasn't left Grover. He has been a practicing physician in our neighboring town since 1977 and has no plans to move. Grover is his home town and he loves it.

Some of the good doctor's patients have been ringing the telephones since last week's paper came out because of a garbled line in a story about an upcoming workshop in which Dr. Talley is to participate called "Three Threats To Life." Somewhere in that story it should have said that Dr. Talley is a former resident of Burlington, not a former resident of Grover. Burlington got in the story because of some material furnished by the sponsoring church.



We told Dr. Talley we'd be happy to re-run the story this week. Sometimes, however, running stories over (as all newspaper folks know) can create more havoc than leaving them alone. For the reader, it is very hard to explain how and why errors can crop up. For the editors, it means red faces. No editor likes to see errors in his newspaper. And our editors always caution reporters that birth, marriage and death are the three most important occurrances in a person's life. So get it right in the paper, they tell us.

"Three Threats To Life" is a workshop on dealing with serious il-Inesses. It will be held Feb. 3 and 4 at the First Baptist Church in Grover but pre-registration is required. To pre-register, send \$5, which includes cost of materials, refreshments and Saturday lunch, to First Baptist Church, PO Box 237, Grover, N.C. 28073 or for more information call 937-7193 or 937-9186.

Topics to be covered will include grief, facing death, the family's role and the diseases as they relate to theology. Dr. Talley will open the workshops on Friday night at 7 p.m. Feb. 3. As a family doctor in Grover, Dr. Talley said his interest is in the person's feelings about cancer, heart disease, etc. but that he will also talk about the technical side of the diseases in Grover language.

Other topics will be led by Rev. Bobby Gantt, pastor of the host church, Rev. Harold (Hutch) Hutchinson, pastor of Shiloh Presbyterian Church, Dr. Susan Miller, Director of Pastoral Counseling at Baptist Counseling Center in Charlotte, and Rev. Tom McNeal, Director of Pastoral Training at Baptist Counseling Center in Charlotte. Sessions on Saturday, Feb. 4, will begin at 8:30 a.m. and will close at 4 p.m.

Pastor Gantt said the Grover ministers got the idea for the workshop to help their local congregations. They became alarmed about the increasing fatal illnesses among members of their own congregations. They then invited the local physician and professional counselors to take part in the program and are opening the sessions to all interested persons.

The workshop leaders say the program should be beneficial to the entire community. Heart disease, cancer and stroke, are three lifethreatening diseases which have touched many lives in our communities. How to cope with them and how to learn to live again after loss are timely topics we would all learn from.

We, as employees of Southern Bell would like the opportunity to express our opinion and concern regarding the "lifeline Service" proposal offered by our company.

We realize the need for a rate hike to be able to continue to exist without the revenue we once had, due to divestiture. However, we also realize that the increase will be a hardship on some of our customers particularly our senior citizens and disabled people which are on low and fixed income. Telephone service is practically essential to these customers, due to frequent illness and other emergencies. We feel the "Lifeline Service" should belong to these people.

It has been proposed, by our company, that this service be offered to "State Welfare" recipients. We disagree. We agree that there are some people receiving welfare which are indeed entitled to it, however, a lot of people receive benefits when the need is not justified.

Our Vice President, Jere Drummond, in a conversation with Brian Thompson with the WBTV News, stated that at this time the "minimal service at a reduced cost" was not proposed for our Social
