NOTICE IS HEREBY GIVEN that a hearing will be conducted before the United States Bankruptcy Court on Tuesday, 11 December 1984, at 9:30 A.M. at the United States Bankruptcy Courthouse, 401 West Trade Street, Charlotte, North Carolina at which the Court will consider any objection to the Trustee's proposed dismissal of the above-captioned adversary proceeding.

NOTICE IS FURTHER GIVEN that any party objecting to this proposed settlement must make a written objection stating the reasons for the objection; such party must by 5:00 P.M. on Monday, 10 December 1984, deliver such written objection to the Court, at its address below and must also by that time deliver a copy of the written objection to the counsel for Debtor at his address below.

NOTICE IS FURTHER GIVEN that all creditors of the Debtor continue to be restrained from foreclosing upon any of the property of the Debtor or from, in any form or manner, interfering therewith, or from instituting or prosecuting any legal action against such property.

A summary of the terms of the Trustee's proposed dismissal is as follows:

Based on information furnished to the Trustee by the Debtor and its President, Donald L. Lovelace, in the petition of the Debtor, at the first meeting of creditors, and in conferences, the Trustee did on 6 May 1982 file an adversary proceeding against Eugene Jessie Wright, Wright Way Trucking, Inc. and M & J Financial Corporation.

The Trustee has now determined that the information furnished him by Mr. Lovelace is materially erroneous. In light of this new information, the Trustee no longer believes the claims merit prosecuting.

In summary, and based upon information furnished the Trustee, the Trustee's adversary proceeding alleges:

1. The Debtor was purchasing a 1979 Peterbilt tractor and a 1978 utility trailer from Eugene Jessie Wright under a written contract.

2. The balance owed by the Debtor under the agreement was \$35,000.

3. The truck and trailer were worth \$55,000.

4. The truck and trailer were delivered to Eugene Jessie Wright on 22 December 1981, and the transfer was either a preference in the amount of \$55,000 or a fraudulent conveyance.

In fact, it now appears:
 1. The "Lease/Purchase Agreement" under which the truck and trailer were being leased/purchased discloses:

(a) It shows "Eugene Jessie Wright" as the lessor/seller. In fact, the truck and trailer were owned by "M & J Financial Corporation" and leased to Wright Way Trucking, Inc. Therefore Eugene Jessie Wright had no right to make such a contract.

(b) It shows "Ira Wade Allen and Donald L. Lovelace d/b/a Mission Transport, Inc." as the lessee/purchaser. The Debtor is Mission Transport, Inc.; neither Ira Wade Allen nor Donald L. Lovelace is a debtor in this bankruptcy. Therefore, the Debtor's estate on its face has no interest in this truck and trailer.

(c) It shows that the lessee/purchaser paid the

Lessor/seller \$7,000 and assumed the obligation to pay M & J Financial Corporation whatever was owed—without stating the balance.

2. The total balance owed M & J Financial Corporation was \$33,336.10 on the truck and \$17,219.02 on the trailer—a total of \$50,555.12. M & J Financial Corporation believes the truck and trailer were worth approximately \$40,000. Even using the Debtor's market value estimate of \$55,000, makes it evident that there is at best de minimis net equity to benefit general creditors of the Debtor's bankruptcy estate.

In other words, even if the Trustee overcame all of the technical defenses of the defendants brought about by the Debtor's careless contract, there would be no net recovery to the estate after attorney's fees and other litigation expense, since M & J Financial Corporation would get the first \$50,555.12, plus its attorneys fees!

The Trustee proposes that the Court enter a Consent Order dismissing the pending adversary proceeding.

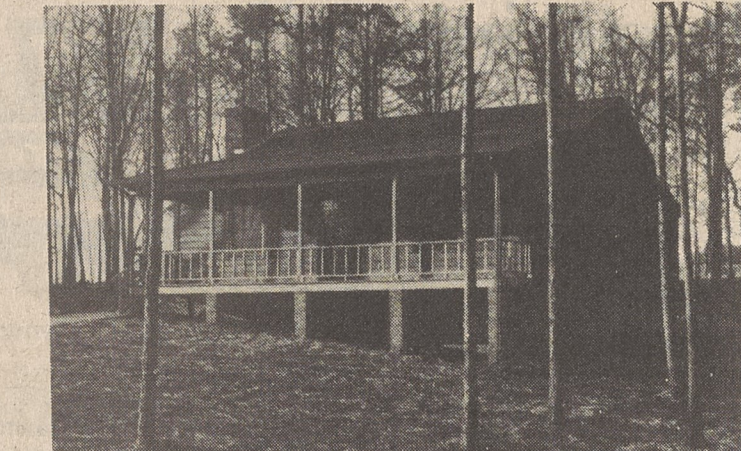
