
Pure and simple, the stupid NCAA rules encourage honest people to cheat every day and therefore to lose a sense of

Where I come from, we thought, the kids who practice all summer in the sun should be permitted to demonstrate their off-season efforts by killing teams who used their summers for lounging around, drinking Kool-Aide, playing badminton, and enjoying recreational swimming.

Can anyone explain why a group of dedicated kids should—via etiquette—beat a group of undedicated kids by only fifteen points when they are capable of winning by forty? You know players—like newspapers, AND college and pro recruiters—care about things like point averages. And you know there are many times when an individual must sacrifice his personal stats for the good of the team. But why should a kid sacrifice his personal stats for the good of etiquette?

"That's different," you might say? But it's different too if the kid willing to win by seven, instead of ten, has a real need for money and has nowhere to get it.


"Wait till you get in the pros. Be patient," people say smug-ly, forgetting that 95 per cent of the kids don't ever get in the pros, forgetting that eighteen year olds can hardly be expected to be more intelligent than the adults who make stupid rules to encourage cheating in the first place.

In the insane climate of NCAA rules, an aberration just doesn't seem that bad some times. If they put some Tulane players in prison, it would be nice if they could at least throw in a few NCAA officials with them. What THEY do in the name of sport and "cronyism," I call theft.
