English For Immigrants

New educational programs may make things easier for people who speak foreign languages and for the merchants, teachers and others who deal with them.



Immigrants who learn English are better able to find jobs and become self-supporting.

Many immigrants who speak Spanish do better in school and are better able to find jobs and become self-supporting if they learn to speak English, educators agree. That's why so many Americans support the ESL (English as a Second Language) programs funded in part by the Campaign for Human Development, an agency of the United States Catholic Conference.

In Texas, the CHD-funded Liceo Sylvan Project, which teaches English to Hispanics, runs a Spanish Teaching Co-operative, a Sewing Co-operative and a Food Buying Co-operative effort. In Washington, it funded the *Proyecto Educativo* at Heritage College. Working with volunteers and other schools, the college offers ESL classes, citizenship, high school equivalency diploma preparation and Spanish literacy for Hispanic adults. *Proyecto* is currently completing ESL curriculum materials relevant to Hispanic farmworkers. Future goals include training new leaders among the under-educated Hispanic adults.
