ADMENDMENT TO CHAPTER 16 **OFFENSES AND**

MISCELLANEOUS PROVISIONS AND MORE PARTICULARLY SECTION 16-19, thereunder

Be it resolved, by the city council for the City of Kings Moutain, that Chapter 16 Section 16-19 of the Code Ordinances for the City of Kings Mountain, should be amended in its entirety, and that Section 16-19 will now be entitled "Section 16-19. IN-TOXICATING BEVERAGES.", which shall read as follows:

16-19 INTOXICATING SEC. BEVERAGES

(A) Prohibited

It shall be unlawful for any person to possess, consume, sell, distribute, or display any fortified wine, spirituous liquor, mixed beverages or malt beverages, upon any premises or property owned by or in the possession of the City of Kings Mountain, North Carolina, unless specifically authorized by resolution of the City of Kings Mountain, North Carolina.
