AN ORDINANCE ESTABLISHING A NEW PERSONNEL POLICY FOR

THE CITY OF KINGS MOUNTAIN, NORTH CAROLINA THAT, WHEREAS, the City of Kings Mountain employs over 170 people to provide municipal services to the citizens of Kings Mountain; and

WHEREAS, the organization and maintenance of a workforce that large requires detailed written policies regarding working conditions, pay, overtime, benefits, work rules, disciplinary actions, and other aspects of personnel administration; and

WHEREAS, as part of a comprehensive management study conducted in 1988, the City received a draft Personnel Policy, which an ad hoc personnel committee of the City Council has reviewed and revised; and

WHEREAS, said committee has recommended the attached policy as the official personnel policy of the City, superseding the existing personnel policy and any informal, unwritten policies;

NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED by the City Council of the City of Kings Mountain, North Carolina, in Regular Session assembled this 28th day of March, 1989, as

Section 1. That the document labeled "City of Kings Mountain, North Carolina Personnel Policy," which is attached hereto, and made a part of this Ordinance by reference, is hereby adopted as the official personnel policy of the City of Kings Mountain, North Carolina; and any personnel policies, written or informal, that conflict herewith are hereby repealed to the extent of such conflict.

Section 2. That this Personnel Policy shall supersede the Personnel Policy previously adopted on February 8, 1984.

Section 3. That this Personnel Policy shall be and remain in full force and effect from and after the date of its adoption.

AN ORDINANCE AMENDING CHAPTER 11 ½ OF THE MUNICIPAL CODE OF

THE CITY OF KINGS MOUNTAIN, NORTH CAROLINA THAT, WHEREAS, the City of Kings Mountain owns the John H. Moss Reservoir, which provides City residents a plentiful supply of water and additional recreational facilities; and

WHEREAS, the City Council has previously established the John H. Moss Lake Authority, with certain duties and powers relative to the protection and use of said reservoir; and

WHEREAS, it is deemed in the best interest of the City of Kings Mountain to decrease the length of terms from five (5) to three (3) years, and stagger the expiration of terms;

NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED by the City Council of the City of Kings Mountain, North Carolina, in Regular Session assembled this 28th day of March, 1989, as follows:

Section 1. That Chapter 11 1/2 of the Municipal Code of the City of Kings Mountain, North Carolina is hereby amended by deleting existing Sections 11 1/2-11 and 11 1/2-12 and substituting the following language in its place:

ARTICLE II. AUTHORITY

Sec. 11 ½-11. Established; members, appointment.

The City Council of the City of Kings Mountain is authorized and empowered to create and establish an authority to be known as the "John H. Moss Reservoir Area Authority." The authority shall consist of seven (7) residents of the City of Kings Mountain selected by the City Council of the City.

Members whose terms have not yet expired will be allowed to complete that unexpired term with an amended expiration date of December 31, 1990.

Effective the date of this Amendment, three (3) members shall be appointed for terms of three (3) years and two (2) members shall be appointed for terms of two (2) years.

The terms of the initial appointments for three (3) years shall expire December 31, 1992. The terms of the initial appointments for two (2) years shall ex-

pire December 31, 1991. After the initial terms expire, all subsequent appointments shall

be for terms of three (3) years.

Vacancies occurring for reasons other than expiration of terms shall be filled by appointment of the City Council as they occur for

the period of the unexpired term. Sec. 11 ½-12. Organization, meetings, quorum.

Following adoption of this Amendment and appointment of all of the members of said Authority, the Authority shall hold its first meeting within thirty (30) days at which meeting the Authority shall elect a chairman, a vice-chairman and a secretary.

The chairman and the vice-chairman shall be members of the Authority, but the secretary may be either a member of the Authority or an employee of the city. These officers shall perform the duties usually pertaining to such officers.

In December of each year, the Authority shall meet and elect a chairman. The term of the chairman and other officers shall be one year, with eligibility for reelection. The Authority shall adopt rules for transaction of its business and shall keep a record of its members' attendance and of its resolutions, discussions, findings, and recommendations, which record shall be a public record. The Authority shall hold at least one meeting monthly, and all of its meetings shall be open to the public. There shall be a quorum if a majority of the appointed members are present.

From and after its organizational meetings, the Authority shall have the powers and duties herein provided. (Ord. of 12-8-73, 2; Res. of 8-13-84)

Section 2. That this Ordinance shall be and remain in full force and effect from and after the date of its adoption.
