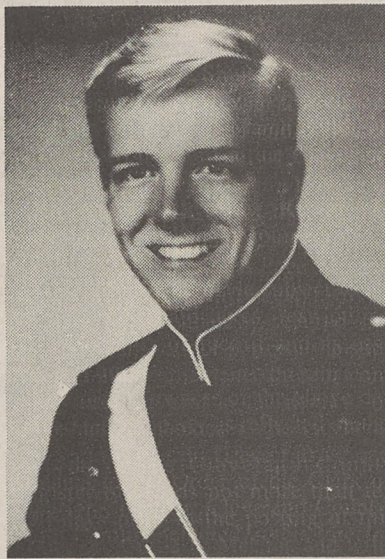


Academy Graduate
