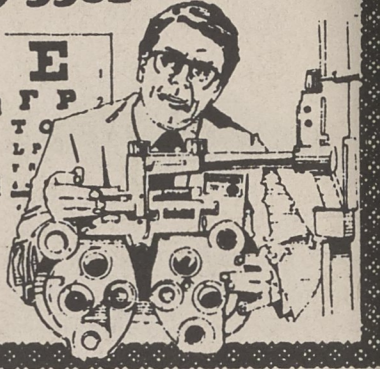

Adjustment. The parking lot construction, he said, would also be subject to Section 73 of the Kings Mountain Zoning Ordinance titled, "Special Exception for Off-Street Parking in Residential Zones." White said Cablelink officials have discussed use of the property with adjacent neighbors and have indicated no objections at this time. Formal notification of adjacent property owners would be issued by public advertising and letter prior to public hearing. White said Cablelink is anticipating a major addition and a major increase in its number of employees.

The Board set public hearing for Aug. 29 at 7:30 p.m. on zoning request from Kathleen M. Bridges, PO Box 722. Mrs. Bridges plans to open a restaurant on her property fronting 125 feet on the east side of York Road south of the intersection of Mauney Avenue and York Road. The property is currently zoned Neighborhood Business. Bridges is requesting General Business zoning.

In a formal resolution the board returned to meeting once a month. The resolution stated the board would meet on last Tuesday nights and set the dates of Aug. 29, Sept. 26, Oct. 31, Nov. 28, Dec. 19, and Jan. 30, 1990. The Board will initiate its new regular meeting schedule on Aug. 29. City Manager Wood said a brief, special meeting must be held on Aug. 8 to formally call for the sale of utility bonds.

to make a significant contribution to the management of our schools."
