

Kings Mountain Police Report

Cleveland County Grand Jury Monday returned a true bill of indictment against Charles Hardy, 35 of Kings Mountain. He was bound over for trial in Superior Court for first degree murder in the slaying of his wife, according to Det. Lt. Richard Reynolds, investigating officer.

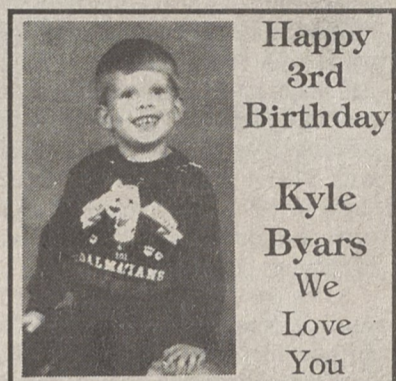


