## Pfc. Johnson returns from Okinawa

Marine Pfc. Brian A. Johnson, a 1991 graduate of Kings Mountain High School, has returned from Okinawa, Japan with 2nd Battalion, 8th Marines.

The battalion from Second Marine Division, Camp Lejeune, participated in training exercises at a number of training areas in Okinawa, mainland Japan and in the Republic of Korea. While forward-deployed in Camp Schwab, Okinawa, the battalion was engaged in aggressive jungle and mountain training.

The battalion deployed to Pohang, Korea where Marines conducted mountain warfare training at the Korean Marine Corps Mountain Warfare Center. This included repelling, rope bridge operations and mountaineering skills. The battalion also participated in company level training with Korean Marines from the First Korean Marine Division.

Elements of the battalion deployed to Camp Fuji, Japan for live fire exercises utilizing mortars and machine guns. The battalion

also participated in helicopter rope suspension training and a tactical Air Control Party with live close-air support and completed a logistics readiness evaluation.

## KM inventor creates new microwave cookware

If you make a better hamburger, will the world beat a path to your door?

Kings Mountain inventor, Ken Bush, will soon know the answer to that question. He has created a new line of microwave cookware specifically for meat.

"Good Health Microwave Cookware" is designed to provide a healthier and more effective way to cook meat in a microwave oven. The cookware set is available for \$29.95 plus shipping and handling by calling 1-800-432-5807.

"I tried to cook hamburgers on plates in my microwave and the result was usually a greasy mess in the oven and burned spots on the meat," said Bush. "When I tried to buy microwave cookware for meat, I discovered that no one provided such a project. So, I decided to make my own."

After contacting microwave oven manufacturers to learn about microwave characteristics such as "hot spots", and working with a plastics design engineer on a prototype of the cookware, Bush filed for a patent. He was granted the patent on February 5, 1991.

Good Health Microwave Cookware cooks most types of meat, including hamburgers, bacon and pork chops, in a microwave oven.

Bush says it reduces fat and cholesterol by separating the grease from the meat. Meat cooks in an elevated, slotted container.

The grease drips into a second container underneath the meat, keeping the microwave clean. Meat cooks more quickly than it would on a plate in the microwave. Good Health Microwave Cookware can be used to steam vegetables in a microwave. The plastic cookware is dishwasher safe.

Bush has received assistance with the development of this project from Service Corps of Retired Executives, which assigned a team to help him locate financing and to assist with other aspects of his business.

A 1981 graduate of Kings Mountain High School, Bush is no stranger to inventions. In junior high, he researched a method of separating oil from shale. "I gave the idea to a company and it put the company on the stock market," said Bush. "That convinced me that you can make money from ideas."

Bush's company, New Technology Marketing Inc., specializes in problem solving. Other projects that he is undertaking include an inexpensive home alarm system and a Nintendo game.
