### **Kings Mountain Police Report**

Two Kings Mountain businesses, Handy Pantry on Cleveland Avenue and Pizza Hut on US 74 and Spring Street, were robbed by suspects wielding hand guns last

Kings Mountain Police are investigating the robberies.

An undetermined amount of cash was taken by a white male who demanded money by pointing a gun at a clerk about 1 a.m. June 1 at Handy Pantry on Cleveland

The suspect is described as a white male five feet nine inches tall and weighing 180 pounds. The suspect was reportedly under the influence of alcohol and slurred his speech. He was reported to be clean shaven and wearing a white tee shirt and dark shorts. He was reportedly barefoot and approximately age 28-32 with brown hair. He was reportedly holding a dangerous weapon.

Saturday night at 12:17 p.m. a black male and a black female entered Pizza Hut as five employees were closing up for the night. Police said there no customers inside the establishment at the time of the robbery.

A clerk told police that one of the suspects held a gun and demanded money from the cash drawer while the other suspect told all the other employees to lie down on the floor and taped their hands. The male suspect reportedly slapped the cashier and said, "That's to show you I mean busi-

The robbers are described as a black male five feet seven inches tall weighing 175 pounds and wearing a camouflage mask and blue sweat shirt and jeans. The black female was described as five feet five inches tall, weighing 160 pounds and wearing a blue stocking mask with a blue sweat shirt and jeans. She wore white socks and no shoes.

The clerk in the Pizza Hut filled a pizza box with money some payroll checks as the robbers demand-

No one was injured in either incident.
