

## Patrol will be out in force

With the increased traffic expected on the highways during the Highway Patrol will participate in upcoming Labor Day holiday, the North Carolina State Highway Patrol will be out in force, as usual, to assist motorists with safe travel, according to Colonel R.A. Barefoot, Commander of the State Highway Patrol.

Additional emphasis will be placed on all areas of enforcement, with vigorous pursuit of the impaired driver the top priority. Speeders, a leading cause of accidents, and other drivers who violate motor vehicle laws will be cited as well.

As on all major holidays, the Operation C.A.R.E. The nationwide Combined Accident Reduction Effort by state police and highway patrol agencies uses high visibility and enforcement to reduce accidents on our nation's highways.

The Labor Day holiday weekend period begins at 6 p.m. on Friday, September 3, and ends at midnight on Monday, September 6. Last year, 5 people were killed and 1,266 were injured on N.C. highways during the same period.

## Free business counseling set in September in Shelby


