A six-year-old student was suspended from East School this week after a five-inch hunting knife was found in her book bag, according to the Kings Mountain Police Department.

Principal Jerry Hoyle told police that the girl showed the knife to a student last Thursday as school was being dismissed for the day. The classmate told the teacher.

Hoyle said he suspended the girl from school for seven days.

Hoyle said that the child's teacher had talked to the classmates about the danger of weapons and that when one of the children observed the knife in the book bag that he called the teacher.

"I don't really think the little girl knew what danger she or anyone else could be in with a weapon such as a knife," said Hoyle.
