Net income was \$3,462,000 or 30 cents per share, for the three months, compared with net income of \$3,969,0-00 or 33 cents per share for the same period in 1993. The decrease was primarily attributable to the adoption in 1993 of a required change in the method of accounting for income taxes which resulted in a net benefit to Security Capital of approximately \$388,000 for the quarter.

Earnings per share, excluding the effect of the accounting change, would have been 30 cents for the first quarter. The annualized return on average assets was 1.49 percent and the annualized return on average equity was 10.83 percent.

Asset quality remained high with total non-performing assets amounting to \$2.4 million, or approximately one-fourth of one percent of total assets. The allowance for loan losses was \$7.2 million, or 1.49 percent of loans and 307.5 percent of non-performing assets.


