Fireworks display is on

City Council voted 4-3 Tuesday and over objections of the Parks & Recreation Commission and Mayor Scott Neisler to spend \$2500 for July 4th fireworks and to proceed with plans for the annual city-wide Independence Day celebration.

Bruce Clark, Recreation Director, said the Parks and Recreation Committee met Monday and recommended that due to money problems that the city pass July 4th without the traditional fireworks and celebration.

Councilman Jim Guyton, Jerry White and Ralph Grindstaff voted against the proposal. "When we're making cuts and freezing expenses I don't see how we can justify this additional expense," said Guyton. White said he

had a problem spending money for fireworks when other things are needed.

But Mayor Pro Tem Rick Murphrey said that a 4th Celebration might build up the low morale among city employees and good for the community. Councilwoman Norma Bridges and Councilmen Phil Hager and Dean Spears agreed.

"July Fourth is one of the times that the community comes out and I hate to see us eliminate the fireworks," said Hager.

In the only other action of the meeting before the long public hearing on the budget, Council approved 6-1 a one year lease agree-
