stance abuse.

Approved the appointment of Joey Hopper, Rev. John Bridges, Dr. Charles Adams, Sandra Wingo and Rev. Ron Caulder to the Health Council. In addition, the Board approved increasing the number of seats for Middle and High School students from one each to two each, but they will not have voting privileges.

Heard remarks by Tom Sees on the System's Family Life Curriculum. He again asked the Board to adopt an abstinence only sex education curriculum. He also provided Board members with copies of the Students Bill of Rights (freedom to express religious beliefs on school campuses) and asked that they be made part of policy and posted in prominent places in schools.

Heard an update from Dr. McRae on the progress of the renovation of Central School; and approved making the new facility a smoke-free environment. Dr. McRae said the building will probably not be occupied before October.

ed in Kings Mountain, KMDS will be the administering unit; however, McRae said all three systems will be involved in the total operation regardless of its location. McRae said eventually the school will move to a more centrally-located area of the county and at that time the administration would shift to the school system where it is located.

McRae said the Community Task Force, individual citizens and employees of the school system had long expressed interest in an alternative school.

"We're very pleased to be able to see a realistic opportunity to begin this program," he said.

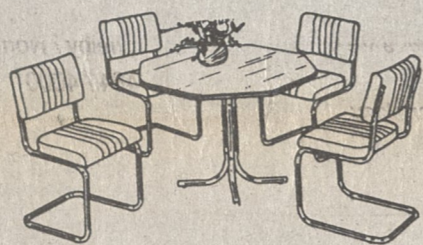
