the state to fix old City Lake but Water Supt. Walt Ollis said the state has extended the time on that project.
"If I had my way I would give both lakes away and let someone else have the worries," said Ollis.
"If we have to get more bids, the price could go up in 30 days," he said.
"We have no money to pay fines to the state and whether we get a buyer or not we need to move ahead and do those repairs," said Hager.

"It's impossible to sell Davidson Lake with a state mandate hanging over us," said Guyton. We can't hesitate. We need to move ahead."
Murphy then called for a vote.
In other actions, the board:
- Designated Councilman Ralph Grindstaff to make recommendations to the ABC Commission concerning the suitability of a person or of a location to receive an ABC permit. As the city's representative, Grindstaff would testify without further authorization at contested case hearings in which the suitability of a person or of a location to receive an ABC permit is an issue.
- Transferred the cable franchise operation from Time Warner Entertainment Company, Limited Partnership, to Time Warner Entertainment-Advance/Newhouse Partnership with no change in day to day management and no change in customer service. The board, however, stipulated, at the advice of Corry, that the contract must include evidence that the company filed a \$1 million bond.
- Approved a change order in the 1991 Community Development Block Grant for administrative purposes in the amount of \$4,746 for Benchmark, Inc. and \$7,900 for Alley, Williams, Carmen and King Inc. Finance officer Maxine Parsons said that the increased work load due to contracts not bid properly and changes in original contracts dictated the increased costs. Parsons said the project has taken over a year longer than originally planned. Grant funds remaining for the project total \$30,000.

- Called for a public hearing for November 29 at 7:30 p.m. on request of developer Jim Lybrand to rezone property on Garrison Drive from NB and R-10 to R-8. Lybrand, of 104 N. Garrison Dr., wants to build luxury condominiums on the corner of Garrison and the street leading to West Gate Plaza.
Adopted a resolution, a standard procedure, for readopting the area under consideration for annexation by the City of Kings Mountain. White said this is the first legal step under the North Carolina annexation laws to permit a city to take in properties in its extra-territorial jurisdiction either by voluntary or involuntary annexation.
- Called for a public hearing at 7:30 p.m. on October 25 at 7:30 p.m. on a request by Mike Heath to rezone his property on Battleground Avenue from R-20 and L-1 to GB and to adopt a resolution fixing the date of public hearing on October 25 for consideration of Heath's request to take his property into the city limits. Heath recently built Mike's Cigo across from Timms Furniture and has acquired adjacent properties. He also recently acquired a nearby beauty shop and the former Welch TV.
- Tabled until the October meeting the appointment of a new member on the board of adjust-
