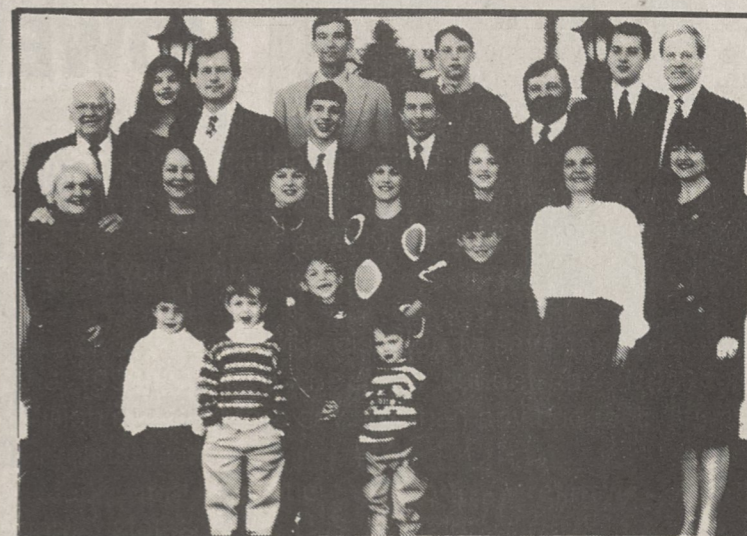


Jack Hunt has done much for our district while in the NC Legislature:
