# Mediator returning to Cleveland County

U.S. District Judge Stanley Sporkin is sending his mediator back to Cleveland County to attempt a settlement in the recent skirmish in the Voting Rights lawsuit between the county board of commissioners and the NAACP.

The two parties were told Tuesday to make a decision in the current dispute on the two minority choices on the county board.

The county commissioners recently chose two individuals the NAACP had objected to and the matter went back to the federal courts.

Les Roark, a member of Cleveland County Association of Government By the People, the new organization challenging the consent decree, said that volunteers have raised \$13,000 of the \$15,000 needed to hire a lawyer to raise constitutional questions about the decree.

The group met Monday night in Kings Mountain and Tuesday night in Shelby to garner sup-

port.

Washburn of Gaines Lattimore is heading up the citizens group and presided at both meetings. Former Kings Mountain mayor Kyle Smith and Sandra Allen and Johnny Short of Upper Cleveland are also on the non-partisan executive committee.

"We want to challenge the entire instrument and if the federal court upholds our petition the present instrument under consideration will be stopped," said Roark, a former legislator and

former mayor of Shelby.

Roark said the provision in the decree that concerns him is the requirement to elect all seven commissioners in 1998 from 14 candidates on a ballot where voters are instructed to vote for only four. "I am against limited voting,"

said Roark.

Roark said he didn't know if limited voting had ever been challenged in the courts but CCAGP is ready to do just that. Roark said that 120 people
