SOUR CREAM COFFEE CAKE JR. LEAGUE OF GEORGIA

1 cup butter or margarine, softened

2 cups sugar

2 eggs

1 (8 oz.) carton commercial sour cream

1 teaspoon vanilla extract

2 cups all purpose flour

1 teaspoon baking powder

1/2 teaspoon salt

1 cup chopped pecans

1/3 cup sugar

2 teaspoons ground cinnamon

Cream butter, gradually add 2 cups sugar, beating until light and fluffy. Add eggs, one at a time, beating well after each addition. Fold in sour cream and vanilla. Combine flour, baking powder and salt; fold into creamed mixture. Pour half of batter into a greased and floured 10-inch springform pan. Batter will be thin in pan. Combine pecans, 1/3 cup sugar and cinnamon in a bowl. Sprinkle three-fourths of pecan mixture over batter in pan. Top with remaining batter. Sprinkle with remaining pecan mixture. Bake at 325 degrees for 1 hour and 10 minutes or until a wooden pick inserted in center comes out clean. Let cool on a wire rack 10 minutes. Remove sides of pan, let cool completely.
