Environmental Waste Reductions is requesting an amendment to the text of the City of Kings Mountain Zoning Ordinance to add to the Table of Permitted and Conditional Uses a use type for L-I zoning that would be covered by Industry Group No. 495 - Sanitary Services as found in the 1987 Standard Industrial Classification manual. The amendment would allow the provision of environmental services to the health care industry to include only the transportation and processing of materials that are not radioactive or defined as hazardous under applicable federal, state or local regulations. In addition such sanitary services would be defined as establishments primarily engaged in the collection and disposal of refuse by processing through sterilization. The amendment would add special requirements which would disallow incineration and outdoor storage. Finally, the amendment would require discharge into the sanitary sewer and operation under state permits.

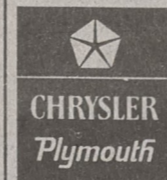
