James M. Hall of Kings Mountain has received a Roanoke Island Summer Institute Scholarship for the 1998-99 year at the North Carolina School of the Arts in Winston-Salem. The award was announced during a special ceremony on the School of the Arts campus.

Hall is a rising college sophomore in the School of Filmmaking at the North Carolina School of the Arts. He is the son of Mr. and Mrs. James M. Hall Sr. of Country Creek Drive.

The Roanoke Island Summer Institute Scholarship is for North Carolina residents. Preference is given to students who have been involved in the NCSA Summer Institute on Roanoke Island.

The North Carolina School of the Arts is the only state-assisted, residential arts school of its kind in the world. The school prepares talented students for professional careers in dance, design and production, drama, filmmaking, music, and visual

The school's-distinguished faculty is made up of professional artists, including a Tony Award-winning Broadway designer, an OBIE Award-winning director, a former ballerina with the New York City Ballet and a veteran of the Royal Ballet Orchestra. In addition, renowned guest artists frequently visit the campus, including The Juilliard String Quartet, Murray Louis, John Lee Beatty and Robert Wise.

AND HANDICAPPED VOTERS Pursuant to Public Law 98-435, the State Board of Elections, by and through its Executive Secretary-Director, hereby advises that certain modifications in North Carolina's voting and registration procedures and facilities have been effectuated for the purpose of facilitating registration and voting by the elderly and handicapped citizens of the State. Please be advised:

(1) Registration facilities and polling places in most elections precincts are now physically accessible to the elderly and handicapped. In those instances where polling places cannot be made accessible. elderly and handicapped voters may vote ballots at curbside or request assignment to an accessible facility for the purpose

(2) Instructions on casting ballots, printed in large type, will be conspicuously displayed at each permanent registration facility and each polling place.

(3) Any voter is entitled to assistance in casting votes from the person of his or her choice.

(4) The opportunity to vote by absentee ballot is available. No notarization or medical certification is required of a handicapped voter with respect to an absentee ballot or application for such ballot. 
