Merger Meeting January 25 in Shelby

The Kings Mountain Board of Education will hold its regular monthly meeting Thursday, Jan. 13 at 7 p.m. at Central School and one of the topics of discussion will be an upcoming meeting with the Board of Commissioners to discuss merging of the county's three school systems.

The commissioners have called a meeting of the county board and three school boards for Tuesday, Jan. 25 from 6-8 p.m. at Cleveland Community College to discuss the issue. The meeting is open to the public but will be a dialogue for members of the four boards and will not include questions from the

audience.
Superintendents of the county's three school systems met with County Manager Lane Alexander Wednesday morning to form an agenda for the meeting. Richard Schwartz, an attorney from Raleigh who was hired by Kings Mountain Schools to represent them in an attempt to head off a merger, al-

so attended the meeting.
Schwartz met with the Kings
Mountain School Board in a
special session Wednesday afternoon and told board members that he had been assured
by Cleveland County officials
and their lawyer that merger is
not a "done deal."

Kings Mountain school officials say they hope the January meeting will be more organized than a meeting they held with commissioners in December. In that meeting there was no formal agenda, and after setting the date for another meeting in January the county commissioners voted to hire a lawyer to represent them in their merger assessment. That prompted the Kings Mountain School Board to hire an attorney, also.


The county commissioner's lawyer, Gil Middlebrooks, has been gathering information from all three school systems since that time. He will review that information at the January 25 meeting. The commissioners will discuss why they are considering merger, and the school systems will be allowed to have staff available to answer any questions the commissioners have.

Kings Mountain School Board member Ronnie Hawkins, who has been a vocal opponent of merger and who recently filed for this year's county commissioners' race, said he hopes the meeting will be positive and will be a first
