Commissioners not listening to the people

To the editor:

On Tuesday, April 18 I attended the public forum regarding the impending school system merger and witnessed a scene that I thought I would never take place in Cleveland County.

I was, in one sense, very proud to hear a student clearly articulate his view and thoughts on what democracy means to him regarding the rights of citizens to be represented fairly by elected officials.

I heard student after student talk of their pride in their schools, pleading with the commissioners to leave their schools as they are, with one student putting it in the very simplest of terms saying, "we're just fine the way we are, leave us alone." In the eyes of the majority of

these Cleveland County Commissioners it seems the superintendents, principals, teachers, parents, or students should have no voice in how our county school districts are to be managed. From all over the county, members of our school districts voiced their opposition to the impending school merger. But, as evidenced by the 5 to 6 seconds it took to approve the merger, even after all the expressed opposition, in the opinion of the people most affected by this action, fell on deaf ears and to minds that were already made up.

One supporter of the merger even dared to compare this pro-cess with that employed to prepare and ratify the Constitution of the United States. This statement was an attempt to justify secret meetings held to determine the educational fate of the children and young adults of our county.

Some of the checks and balances in the Constitution were opposed, violently in some cases. However, when the document was completed it remained true to its purpose of providing enduring guidelines for democracy that includes the rights of all citizens. Yes, even the citizens of Cleveland County some 224 years later have the right to determine their own destiny by democratic process.

When by all estimates at least 80 to 90% of all people affected are against the merger of the school systems of Cleveland County, the decision to proceed with this action by the county commissioners only shows a further erosion of people's rights. This blatant disregard for public opinion has caused our nation embarrassment in


practically every level of our government from the White House on down.

The only reason I heard for the revaluation of the county property taxes in 5 rather than 8 years was to lessen the shock of the increase caused by the revaluation after the full 8 years. This reasoning is now in question. It now appears as if the 5-year revaluation was timed to increase property taxes to coincide with the commissioners' intent to merge the school systems.

I have never been a single-issue voter. I have always tried to consider the broader political perspective even with all the campaign platforms that I have heard in my lifetime. But, this May my vote will be to oust the incumbent commissioners who voted for the merger without a public referendum, and for the candidates who are running against them regardless of their party affiliation.

I am deeply disturbed by the erosion of our collective political voice that now seems to have reached even into **Cleveland** County.
