merger, but because of his experience and knowledge of county issues.

"I have had a philosophy on the School Board that a person who has just been elected shouldn't serve as chairman," he said. "That doesn't mean they're not qualified to serve, but there's a lot of things that they need to learn. There are a lot of things that have been going on that you're not up to speed on, and I think a firstterm person should be willing to put themselves in a place to learn everything they can and be knowledgeable about what they're talking about before they act as chairman.

"Willie has been there and I think he would be a good person to serve as chairman."

McIntosh could not be reached for comment, but all indications are that he will accept the appointment.

Although they haven't discussed it, Hawkins hinted that one of the three Kings Mountain commissioners-elect may be elected vice-chairman.

"I really haven't thought about it," he said, "but it's something we can sit down and work out. I've had a lot of experience as chairman of the School Board and I think I could bring the expertise of being a chairman to the vice-chair position. Mary and Tommy are knowledgeable about what's taking place in the county."

Hawkins said he would not support veteran commissioner Charlie Harry for vice-chairman because of his position favoring school merger.

"Charlie's a friend, but he and I are on the opposite end of the issues when it comes to merger," Hawkins said.

Bridges and Accor said they

being vice-chairman yet, either.
"It hasn't crossed my mind,"
Bridges said. "I'm not worried
about it. Any of them would be

alright with me."
Although the agenda for the December 4 meeting has not been set, the commissioners-elect hinted of some other actions they might propose.

against school merger to be sent to the State Board of Education and Department of Justice, and the possible dismissal of the county's merger attorney, Gil Middlebrooks

"We've got to explore some possibilities to stop merger," Bridges said. "I don't think we can do it ourselves but I think we can ask someone else to do it. They might listen to us and they might not."

Hawkins said he'd like to see a resolution that states the new Board's opposition to merger and that the recent election is proof that the citizens of Cleveland County are opposed to merger. He also said the resolution should state that the current Board feels that the old Board violated state law when it did not include Gaston County Commissioners in the decision because part of the Kings Mountain School District lies in Gaston County.

Another part, he said, should point out the escalating legal expense is not in the best interest of the county and that the county attorney be given the authority to take "whatever means" necessary to stop the expense including, if necessary, dismissing Middlebrooks.

"What I would prefer is that Mr. Middlebrooks see that the new Board is against merger, and he would just withdraw as the attorney," Hawkins said. "That would allow him to take himself out of it, but if it means making a motion that we don't need him any longer I think that would be appropriate."

The commissioners-elect will be in Asheville the remainder of this week attending a school for new county commissioners

sponsored by the NC Association of County Commissioners.


