

KM POLICE REPORT

KM man stabbed

A Kings Mountain man was charged with assault with a deadly weapon inflicting serious injury after he allegedly stabbed his son Thursday at 1305 Northwoods Drive.

The police department said officers received a call at 11:10 p.m. in reference to a fight, and after their arrival they were told that a father had stabbed his son three times.

Officers said the son was not at the scene but had driven himself to his home on Redwood Circle. EMS was dispatched to his home and transported him to Gaston Memorial Hospital where he was treated and hospitalized overnight for observation.

Vincent Leroy Byrd, 44, 1305 Northwoods Drive, was arrested in the incident. He was placed in the Gaston County Jail under a \$25,000 unsecured bond.

The victim was identified as Sha-Keam Dyrell Bernabela, of 2015 Redwood Circle.
