# 2 found dead in KM home

There have been no new leads in what Cleveland County Sheriff's officials are calling a double homicide inside a house at 111 Goodall Street, off Dixon School Road between Interstate 85 and U.S. Highway 29.

Bodies of Ontario Jermaine McCluney, 30 and Bonita Shipp, 39, were found when deputies entered the

residence on Friday, April 19.

The Charlotte Observer reported on Tuesday that McCluney grew up in the Goodall Street house where he died.

Shipp, McCluney's girlfriend grew up in Lincolnton and moved in with Jermaine about six years ago. Shipp was recently laid off, and

McCluney was no longer working at a nearby restaurant, according to the newspaper.

Although it is a murder investigation, no motive or cause of death have been determined.

Both bodies have been sent to Chapel Hill for an autopsy.
