these bonds is \$2.4 million. "This is a historic moment for Cleveland County," said CMRC President John Young, who will manage both facilities. "Our hope and vision for Kings Mountain Hospital is exciting and robust," he said. His excitement was mirrored in the statements made by board members and the applause generated when the final action was taken about 9:45 a.m. following similar action by trustee groups.

Both J. C. Bridges and Scott Neisler of the KM board called the deal a "win win" situation for Kings Mountain and they made the motions to proceed with hospital integration following approval of the trustee advisory council. Other local board members Pat Trammell, chair, Joe Piedmont and John Sullivan concurred.

"It behooves us to move with the times and to be able to compete and keep people closer home for health care," said Neisler, who said that every time he sees the painting of hospital benefactor Lottie Goforth on the hospital wall he looks for a smile on her face.

With the merger on January 1, the two hospital boards will consolidate into one board. There will be eight trustee council members from Kings Mountain and 12 from Cleveland Regional.

The adopted resolutions state that with the new health care system, high quality, patient centered care and customer satisfaction shall remain driving themes for service delivery. The strategy of developing a single health care system in Cleveland County, with two primary acute care providers, is to:

+maximize clinical quality, customer satisfaction and access to care.

+improve the clinical services provided to Cleveland County residents, through expanded centers of excellence in the acute care settings at both Kings Mountain Hospital and Cleveland Regional Medical

+improve local access by minimizing patients leaving the county and the system. +improve the financial via-

bility of both KMH and CRMC.

+assure that sufficient ongoing capital investment is made at the Kings Mountain Hospital location, and the Cleveland Regional Medical Center location, in order to provide excellent acute care services and to maintain and grow market share in Cleveland County and the surrounding region.

+assure that ongoing routine investments and replacement schedules are sufficient to maintain or enhance the competitiveness of Kings Mountain Hospital and Cleveland Regional Medical Center in the marketplace.

+assure that access to care is maximized by service offerings at both the locations, where sufficient volume exists to assure clinical or financial viability.


