BATmobile checkpoint set Friday near KM

The BATMobile is coming to Kings Mountain, looking for drunk drivers Friday night.

Don't expect Batman and Robin, instead, area law enforcement officials will be using the mobile unit to charge drunk drivers at the scene.

The 32-foot-long bus, known as a Breath-alcohol testing mobile unit, is equipped with workstations for two Intoxilyzer 5000 breath test instruments, cellular telephones, computers, officers' workstations, lavatory, search batons, screening tests devices and all other necessary equipment and supplies for processing DWI suspects.

The BATMobile allows officers to test individuals suspected of drunk driving at the checkpoint instead of transporting them to permanent testing facilities.

Police say KM, Shelby shootings are connected

The June 14 shooting death of a Kings Mountain man and the April shooting of a Shelby man are connected, law enforcement officials

Seven men, calling themselves the Chopper Gang, have been arrested in connection with the two deaths.

Johnny Clayton White, 24, of 116 Pearce Court, Kings Mountain, Sergio Meindazz McClain, 19, of 517 Crocker Road, Kings Mountain and Frederick Eugene Moore, 30, of 108 Pearce Court, Kings

charged in the shooting death of Jeffery Todd

Rogers, 32, was shot June 14 at his temporary residence at 114 Pierce Drive, Kings Mountain.

Walter Lee Chambers, 23, of 304 Longbranch Road, Grover, David Rashaun Chambers, 20, of 116 Pearce Court, Kings Mountain, Derrick Lee Wilson, 24, of 108 Pearce Court, Kings Mountain and Maurice Alexander Chambers, 22, of Foxcroft Circle, Shelby have been charged in the April 29 shooting of Rajshawn Chatman. That shooting occurred on Shannonhouse Street in Shelby.

Investigators have recovered some firearms that may be linked to the crimes. The State Bureau of Investigation is currently analyzing the weapons.

Investigators have also impounded a blue Chevrolet suburban that belonged to Derrick Wilson. The vehicle was seen at 114 Pearce Court shortly before the homicide

and was seen leaving the scene following the incident.

The arrests come out of a joint effort of the Cleveland County Sheriff's Office, Kings Mountain Police Department, Shelby Police Department, North Carolina SBI and the Blacksburg Police Department.

A Kings Mountain man was charged with cruelty to animals after investigators found 39 neglected cats and several dead cats in

his home Thursday. Paul Melton of 314 Cansler Street was given a criminal summons but was not arrested, according to Sam Lockridge, coordinator for health services at Cleveland County Health Department.

Melton is working with the City of Kings Mountain to determine if the house can be brought up to standards, Mayor Rick Murphrey said.

The investigation began when City of Kings Mountain codes director Holly Black contacted Lockridge's office. She was concerned about Melton's health, Lockridge

said. Lockridge, code officials and social workers visited the home Thursday.

Social workers obtained a court order to have Melton evaluated physically and mentally, Lockridge said.

The Cleveland County Health director declared the house an imminent health hazard Friday.

After examination by a local veterinarian, the 39 cats were euthanized because of respiratory illness, Lockridge said.

This is not the first time that the health department has been involved with Melton. Eight years ago, he had 120 cats taken from his home. Those animals were not in the same neglectful condition as the animals found last week.

"He just had way to many," Lockridge
