

The purpose of this hearing is to receive citizens comments concerning an amendment to Community Development Block Grant (CDBG) program (02-C-1030).

The City received CDBG grant in the amount of \$219,632 to install sewer in the West Gold Street area. That project is complete. Approximately \$51,475 in CDBG funds remain. The City proposes using those funds to install approximately 1,900 linear feet of 8-inch water line and two fire hydrants along Tabernacle Church Road.
