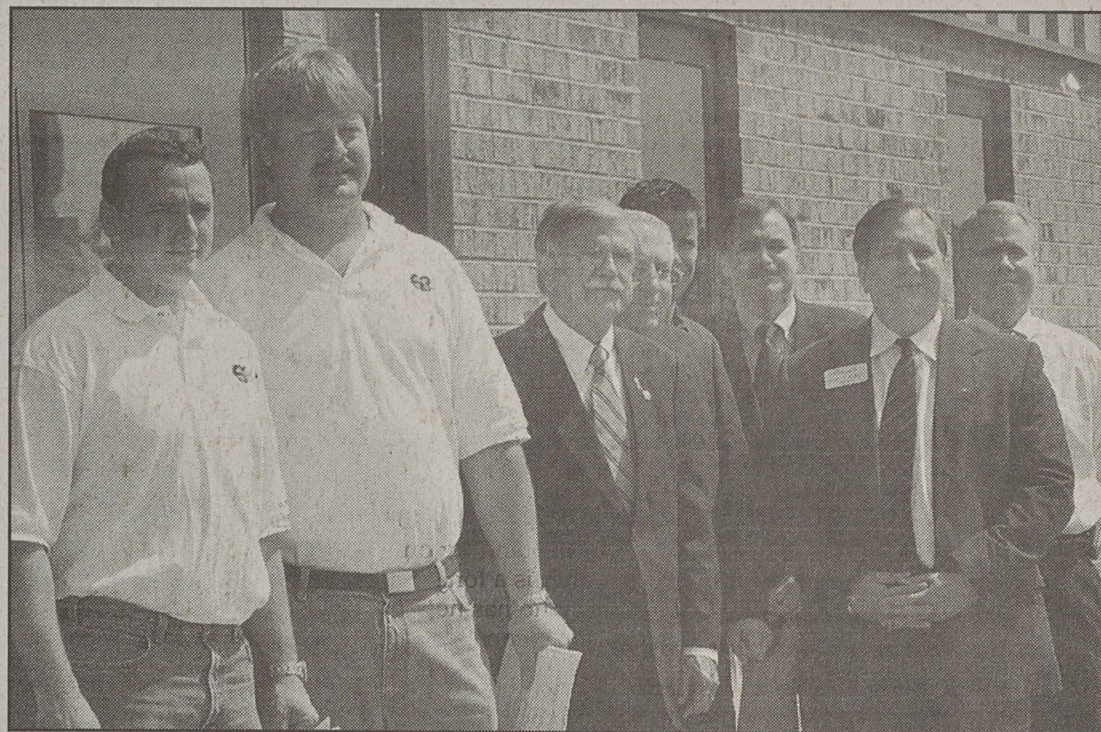
Motorists using N.C. 216 last week got a surprise when they encountered a new traffic pattern near Dixon School Road.

The former Wirtz Manufacturing building on South Battleground Avenue has a new occupant. S3 Technologies has moved its facility from Mooresville to Cleveland County.

S3 Technologies makes carbon fiber components for the racing and sports industries. Products include light weight body work and structural components for the Grand-Am Daytona prototypes, LeMans LMP, IRL

cars, Formula Mazda and several GT cars, according to a press release from the Cleveland County Chamber of Commerce.

The move to Cleveland increased the company's work space from 4,000 square feet to 18,000 square feet.

Kings Mountain Mayor Rick Murphrey called the company a "high profile business" which will attract other businesses to this area. S3 will purchase water from the City of Kings Mountain.

The company employs seven full-time staff members.

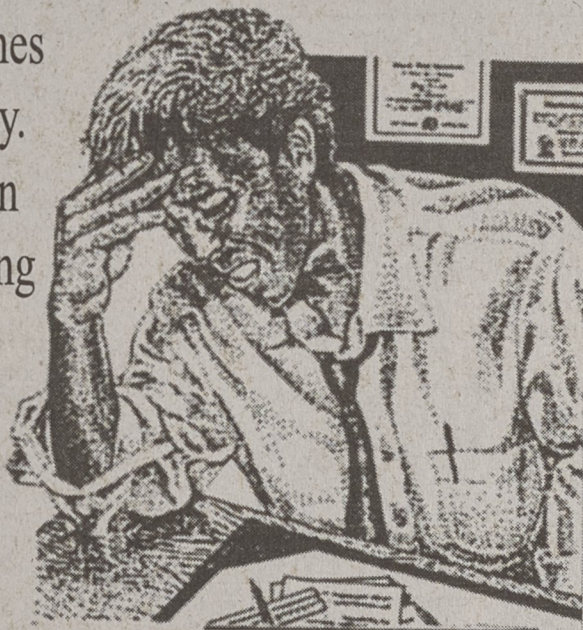

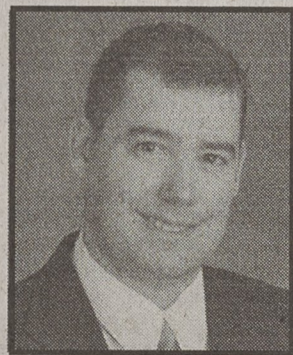
