The North Carolina Department of Transportation (NCDOT) will hold the above Citizens Informational Workshop on Tuesday, October 18, 2005 between the hours of 4:00 p.m. and 7:00 p.m. in the Mooresboro Woman's Club, 308 Main Street, Mooresboro.

The purpose of this workshop is for NCDOT representatives to provide information, answer questions, and accept written comments regarding this project. NCDOT proposes to upgrade US 74 to full access of control from Mooresboro to the proposed Shelby Bypass (TIP No. R-2707). Full control of access means that preference is given to through traffic by providing access to a highway only at interchanges. There will be no intersecting roads or direct private driveway connections to US 74.
