## 2-year term is our only alternative to recall vote

To the editor:

When the so-called "smart people" abandon the political system, they are replaced by people who succumb to self-serving and partisan interests; inappropriate and ill-informed decision making; actions that are harmful in the long term and the ultimate result - corruption of the system for the benefit of a select few.

In the long term, however everyone gets to pay for the mistake of the self-serving and incompetent.

I believe the present political administration does not understand that we know the difference between an effective leadership and one that must be replaced.

Our problem as citizens is that we have been indifferent to this continual downward slide.

Do you really trust this political administration to work in your best interest?

There is no recall for political wrongdoing in NC, therefore our only protection is the two year term.

Before this vote is taken by City Council, I want my political representatives Rick Murphrey, Houston Corn, Dean Spears and Mr. (Rodney) Gordon to answer publicly in a rational manner the following questions. Note: Mr. Gordon is in his first term so I would not expect him to know all the answers.

1 - How many times since the founding of KM in 1874 have all council members and the mayor been voted out at the same election?

2 - If Mr. Murphrey is concerned about stability, does he think that 10 years as mayor is instability?

3 - We have had a revolving door of city managers and "interim city managers" since 1988. This adds up to about one city or "interim manager" every two years. Each of these city managers have one thing in common: they said they were (pick a term) forced out, coerced, resigned for personal reasons, intimidated, asked to do illegal acts, etc. Who do you think is responsible for making KM the laughing stock of Cleveland County and the state of NC?

4 - Since the change in charter to two year terms was done by petition, why do you not trust the people to express their opinion this time?

5 - Why did you decide to hold the public hearings at times other than at regular meeting dates?

6 - Why did you decide to avoid the proper management procedure of a city manager? Had you endorsed the proper procedure, the city would have received 80 to 90 applications from qualified, experienced persons.

7 - How do you know for certain that every utility rate payer is in their correct payment schedule?

8 - Explain why you are continuing to waste time and money on a so-called "second lake" which will never happen.

9 - What is your plan for completion of the water line into town? The original cost was about \$10 million. The latest cost is about \$12 million.

10 - Since the water plant is running at about half capacity and the plant can be upgraded from its present capacity of 8 MG/D (million gallons per day) to 24 MG/D, why are you making no plans to upgrade the plant? The plant started to operate in 1974 and is our lifeline. The cost to upgrade would probably cost \$10 million. If this is correct, please give us the facts.

11 - Since the lake is silting in at the rate of 10,000 cubic yards (engineering estimate) annually (since 1974), explain your plan for correcting this problem. I am not concerned that residents at the upper end of Moss Lake may have beach-front property in the future.

12 - How did you justify raising utility rates but not bothering to cut the budget in any significant way? Do you plan to do the same again this year?

13 - Please explain to the public why you actually deserve a four year term.

We have a very serious problem in this political administration. We know for certain that the city manager system that our charter provides has been virtually destroyed. It exists in name only. Do you believe that this happened by a natural process or accident?

Do you believe that all those city and interim managers were unequalled?

It will take time to correct the situation of inappropriate behavior on the part of our present political administration.

My solution is this: No matter what this mayor and council decides on the four year term, it is time to decide how you want your city business to be conducted. Is it finally time to use your vote to remove every member of this present political administration? Do you really believe that this is any way to run a \$30 million business? What do you think?

## Gene Goforth - legend, friend

Sometimes in life you're blessed to meet and get to know a true friend.

Eugene Goforth, who died last Saturday just a few days shy of his 88th birthday, was such a man.

I met Gene back in the early 1960's when I was a young sports writer at the Kings Mountain Herald. Gene was a city commissioner.

A few years later I was writing sports for the Gastonia Gazette and was assigned to do a feature story on Gene, who was an outstanding pitcher on the high school baseball team at KMHS in the 1930s, and later in the military and professional ranks.

We sat down in his living room on Landing Street and talked baseball for hours. I taped that session - but the Good Lord only knows what ever happened to the tape.

From that day on, I knew Gene was much more than just a good baseball player. He was a remarkable man, who loved God, his family, the city of Kings Mountain, and all of his many friends. I don't think Gene ever met a stranger; if he did, he quickly turned him into a friend.

Over the years Gene, David Hughes, Billy Hughes and I had some wonderful experiences fishing the small lakes around here and the big one they call the Atlantic Ocean along the North Carolina coast.

Whether you caught fish or not - the other three always did, sometimes I didn't - you always had a great time because Gene would keep you rolling in laughter. Sometimes when you landed a decent fish, Gene would say "good boy."

Whether it was playing a practical joke, telling a good joke (most of which cannot be repeated in print), or recalling some of the humorous moments he experienced in pro baseball, trips were always a hoot.

I'm not going to say for a fact, but Gene may have been the last surviving member of Kings Mountain High's first championship baseball team of 1935. Gene was one of four outstanding players on that team to sign pro contracts. Gene made it as high as AAA ball with the Chicago Cubs, where he played against Dodger legend Gil Hodges and Chuck Connors of "Rifleman" fame. Gene was a freshman on that '35 team. Although he wasn't considered the ace, he went on to become the ace the next three years, closing out his prep career in 1938 by being named the KMHS athlete of the year. In addition to his baseball exploits (his 21-strikeout performance against Newton in 1938 is still a school record and he pitched a no-hitter in pro ball), he was also an outstanding basketball and football player.

I'll never forget Gene talking about playing basketball on the stage of Central School. The baskets were attached to the walls. With Gene being the team's biggest player at 6-6, of course he played center and when the inside players began "banging the boards" for rebounds they were really banging the boards of the stage walls.

I'll also never forget the time in 1992 when I was compiling a history of KMHS football. Newspapers from the early days didn't cover sports like they do now and it was almost impossible to find complete records of teams in the 1920s and 1930s. I couldn't find anything from the 1936 and 1937 teams except a pre-season schedule and I asked almost everyone that played on those teams what their won-lost records were and they all said

Oh, I forgot, he can't move on. He made the mistake of insulting minorities. You can't insult minorities in this country.



Gene's professional baseball career was interrupted twice by military obligations - one stint of duty just prior to World War II and the other during the war - and even though an accident during his service years cut short his pro career, he cherished those years in the Army.

He was taking a transmission out of a military truck one day when a jeep pulled into the garage and hit the jack handle, causing the truck to fall on Gene's pitching shoulder. He never had his pre-war velocity after that.

His funny stories of his professional years are legend, just as Gene was a legend. Had he chosen to leave his beloved Kings Mountain he could have made a good living as a comedian. Believe me, today's comedians like Jeff Foxworthy and Larry the Cable Guy are dull compared to Gene Goforth.

Gene's favorite line when we'd get into the truck to go fishing, and when we launched the boat into the water, was "And they're off, said the tomcat" followed by a line about what happened to the tomcat when he got caught in a barb wire fence. Anyone who ever fished with Gene knows the finish. Anyone else can ask me.

I don't think there will ever be another day that I don't think of Gene Goforth. He made that kind of impact on people.

He was a "good boy" who is off to a better place where I hope there are plenty of lakes and ball fields. If there are, though, I think it will be a long time before Gene will be on them. His first priority after meeting God will be to go all over Heaven and make friends of everyone.

Sharpton has never apologized to anyone, nor has Jackson apologized for referring to New York as "Hymie Town."

Imus, first of all, is a flaming liberal. He also has an acid tongue. I've never considered him a racist. I always thought of him as an equal opportunity insulter. His recent comment, which will probably end his career, was not the worst thing I've ever heard him say.
