The Cleveland County Chamber of Commerce is now accepting entries for Kings Mountain's 10th Annual Business Showcase.

The Showcase, "By the Tracks," kicks off February 26 from 5:30-7 p.m. at City Hall. Businesses will continue to be displayed at City Hall until March 21.
