Thieves swipe tools, heist trailer too

Tool thieves loaded up a 6x12 utility trailer with several thousand dollars worth of tools during a break-in June 1 at Mark Beach Properties, 411 W Mountain Street.

Kings Mountain Police Cpl. J.C. Shull said the total "haul" by the thieves amounted to more than \$7,000.

Shull said thieves cut the lock from the 2004 cary-on Cargo trailer, removed the tools inside and then made off with the \$3500 trailer plus three nail guns, one arm saw, one Sabre saw, one air compressor, one heavy duty portable saw, six heavy duty drop cords, one tool box, an assortment of mechanics tools, and one bag of battery operation equipment including drill, Sabre saw, flashlight, and cordless drills.

Police are continuing their investigation into the incident.




