Men sought in double tool heist

Jan. 26, 2009 - Mark Anthony Deaton, out on parole and out of money, allegedly endangered the first condition in an attempt to im-

prove the second. Deaton, 47, of 1839 S. Battleground Ave., Kings Mountain, is being sought by Shelby Police for two break-ins that occurred on Jan. 26. Police have also issued an arrest warrant for 29-year-old David Lee Renardo Gilmore, of 207 Freshwater Drive, Shelby.

Both men are charged with felonious breaking and entering, felony larceny, possession of stolen property and injury to real prop-

According to Shelby Police, suspects gained access to Western Carolina Supply Co., at 2245 Kings Road in Shelby, by cutting a chain link fence and stole an assortment of tools valued at over \$600.

A second break-in and larceny curred the same day at City Electric Company, located at 4400 Dixon Boulevard in Shelby, where suspects

seized approximately \$3,800 worth of tools and merchandise, according to authorities.

An investigation by Shelby Police detectives has led to the recovery of the stolen items.

Deaton served time in Gaston County for receiving a stolen vehicle back in 2007. He has also been convicted of second degree trespassing, larceny, speeding to elude arrest, possession of schedule II substance and receiving stolen goods.
