ing 32 counts of embezzlement, he was placed in the Lincoln County jail under a \$30,000 secured bond. Rathbone has previous convictions for sale of cocaine, felony larceny, felony forgery of instrument, felony uttering a forged instrument, felony breaking and entering to a motor vehicle, misdemeanor larceny, shoplifting, leaving the scene of an accident, simple possession of marijuana, resisting a public officer, and several traffic related charges, according to law enforce-
