RESOLUTION OF THE BOARD OF COMMISSIONERS of the CITY OF KINGS MOUNTAIN DECLARING ITS INTENT TO CLOSE CERTAIN STREETS

WHEREAS, the Kings Mountain Redevelopment Commission has determined that certain streets should be closed, in accordance with the Comprehensive Redevelopment Plan of the Neighborhood Redevelopment Project (being NCR-86), and the Board being of the opinion that the closing of such streets is proper and should be accomplished;

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of the City of Kings Mountain does hereby declare its intent to close the following streets:

(a) Davidson Street.
(b) Rosewood Avenue.
(c) That portion of West Ridge Street extending from Watterson Street to Cansler Street.

(d) That portion of Ellis Street extending from Watterson Street to North Tracy Street.
(e) that Portion of North Tracy Street extending from Ellis Street to Parker Street.

(f) That portion of Childers Street extending from Watterson Street to North Tracy Street.

BE IT FURTHER RESOLVED, that a public hearing is hereby called on the question of the closing of said streets for the meeting of November 12, 1979; that this Resolution shall be published once a week for four (4) successive weeks prior to such hearing, a copy thereof shall be sent by certified mail to all owners of property adjoining the streets as shown on the County tax records, and a notice of the closing and Public Hearing shall be prominently posted in at least two (2) places along said streets:

ORDER AUTHORIZING \$40,000 WATER BONDS

BE IT ORDERED by the Board of Commissioners of the City of Kings Mountain:

1. That, pursuant to The Local Government Bond Act, as amended, the City of Kings Mountain, North Carolina, is hereby authorized to contract a debt, in addition to any and all other debts which said City may now or hereafter have power or authority to contract, and in evidence thereof to issue Water Bonds in an aggregate principal amount not exceeding \$40,000 for the purpose of providing funds, together with the proceeds of \$120,000 Water Bonds of said City authorized by an order adopted by the Board of Commissioners on November 27, 1978, which has taken effect, and with any other available funds, for enlarging and improving the water system of said City, including the acquisition and construction of facilities for the collection and removal of sludge from wastewater from a water treatment plant of said City and the acquisition of necessary equipment and any necessary land and rights of way therefore to pay the principal of and the interest on said bonds.

3. That a sworn statement of the debt of the City has been filed with the City Clerk and Treasurer and is open to public inspection.

4. That this order shall take effect 30 days after its publication following adoption, unless it is petitioned to a vote of the people as provided in G.S. 159-60 in which event the order will take effect when approved by the voters of the City at a referendum as provided in said Act.

The foregoing order was adopted on the 5th day of November, 1979, and is hereby published this 8th day of November, 1979. Any action or proceeding questioning the validity of the order must be begun within 30 days after the date of publication of this notice.
