## Workshops Set At KMHS

Teachers in the Kings Mountain School System are getting an opportunity to learn about the free enterprise system and the Cleveland County economic structure as a series of five workshops entitled, "Economic Awareness" begins September 17 at Kings Mountain High School.

Sponsored by Gardner-Webb College through a grant from the Broyhill Academy for the Study of Independent Concepts, and in cooperation with the KM City Schools, Dan Moore, former Shelby High School principal and current director of the Broyhill Academy, is coordinator of the workshops.

Each session will feature a Gardner-Webb professor and a local business leader. Dr. Larry Sale, dean of Continuing Education and Summer School and Keith Griggs, assistant dean and assistant professor of business and data processing will lead the Gardner-Webb group.

The workshops will offer teachers an opportunity to examine their own personal financial situations as well as a chance to learn techniques for teaching economics in the classroom. "We won't be getting into the economic theories of the world," Moore said. He stressed that the aim of the workshops is to examine "practical economics."

During the first workshop, participants examine the free enterprise concept, economic terms and concepts and investment of capital, including tax exempt yields and variable yields.

Other sessions will examine use of capital including methods of obtaining large sums of money and yield expected from capital investments; the relationship of the private and public sectors; government controls including OSHA, ICC, FCC and EPA; and how to build an estate. Participants will also learn how a large corporate firm operates as Jack Vincent discusses Dover Textiles and the history of Porter Brothers, Inc. will be given by Paul Porter and C.C. Guy.

For the teachers who wish to participate, Moore said, "it will be a great opportunity to get to know five of the leading businessmen in Kings Mountain personally, a chance to learn of the inter-workings of successful business operations and gain information that will help with their personal finances."

Local business leaders participating in the sessions include Jake Dixon of Home Savings and Loan, Dr. Charles Blair, Josh Hinnant and Earl Searcy of First Union National Bank, Jim Herndon of J.E. Herndon Company, and John Majors of Eaton Corporation.
