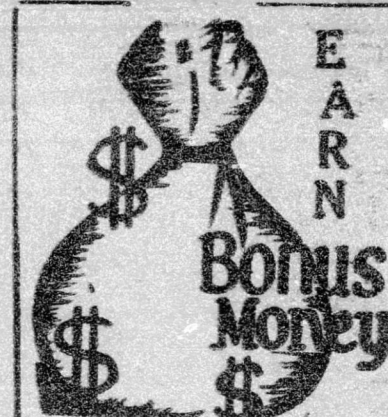

"Catfish" Goes To Jail

Greensboro Native Kills Lover, Drives Off Cliff

NASHVILLE, Tenn.—A 25-year-old medical student murdered her boyfriend here Saturday then killed herself a few hours later in a car wreck.

Miss Anna L. Jackson, of Greensboro, N. C., a senior at Meharry Medical College here, died Saturday after shooting herself with a pistol while driving on Highway 12 about 15 miles east of here. The car plunged down a 100 foot embankment. She died several hours later from "internal bleeding."

The body of Vernal Joseph Roberts, Jr., 27, of Galveston, Texas, also a senior at the college, was found Saturday afternoon in Miss Jackson's apartment. He was shot through the heart with a .32-caliber bullet.

John W. Core, special investigator for the Nashville District Attorney, said Roberts' wife, Barbara, living in New York City is expecting twins "momentarily."

He said "from the best I can get" the two had been living together since Roberts' wife returned to New York last February.

Core, who termed the deaths "apparently a love triangle," said Miss Jackson stopped at a gas station in Ashland City near here before the wreck to telephone a boy at the college to tell him "goodby."

Core said a few minutes later she plunged down the embankment. Miss Jackson was also shot with a .32-caliber bullet, Core said the gun had been found.

Discontent Of Alumni Said Cause

HAMPTON, Va. — Hampton Institute's president, Dr. Alonzo G. Moron, after 10 years, has written a letter of resignation to the board of trustees of the institution. Dr. Moron's resignation is allegedly a result of his reaction to complaints of the trades division regarding about a shift in emphasis. Although there was rumor of a friction between Dr. Moron and the alumni, news of his resignation came as a shock to many "insiders" at Hampton.

Dr. Moron has been charged with stressing an academic curriculum and de-emphasizing the trade courses. He is said to have cited two factors in response to the complaints: the decline in trades course registrations, and the obsolete condition of some of the facilities.

Late Bishop Penick Chaired St. Aug. Board Of Trustees

The Rt. Rev. Edwin A. Penick, bishop of the Episcopal Diocese of North Carolina and chairman of the board of trustees of St. Augustine's College, died Monday night in North Carolina Hospital, Chapel Hill, after several days of grave illness.

Bishop Penick was a great leader, whose efforts during his term of office on the college board resulted in considerable growth of the institution. The college is now fully accredited by the Southern Association of Colleges and Secondary Schools.

Bishop Penick also made many friends for the college

and in the past year made a successful appeal to the National Council of the Protestant Episcopal Church for greater financial support of St. Augustine's. The climax of his fruitful efforts took place during the General Convention held at Miami Beach, Florida in October 1958.

Bishop Penick's activities on St. Augustine's campus kept him abreast of the college and its work. He officiated at confirmation rites during holy week, presided at commencement exercises and

Former Klan Boss Gives Up; Languishes In Jail

LUMBERTON — James W. (Catfish) Cole, former Ku Klux Klan leader, was committed to jail Tuesday to begin an 18-25 month term for inciting a riot of Klansmen and Indians near Maxton.

Cole was expected to be held in Robeson County Jail during this week and then be transferred to Central Prison in Raleigh for assignment.

Cole, a former patent medicine salesman from Maxton, S. C., was sentenced in Robeson County Superior Court shortly after the Jan. 18, 1958, riot near Maxton. The sentence was upheld by the State Supreme Court last month.

He had said he would appeal to the U. S. Supreme Court but there have been no official attempts to perfect the appeal.

A capias for his arrest was issued as soon as the official Supreme Court ruling was received by the Superior Court clerk. He was returned here from his South Carolina home shortly after the capias was issued.

Cole, as leader of a Carolinas Klan group, had scheduled a rally near Maxton on the date of the offense for which he was subse-

Lemuel Graves, Native Of Raleigh, NY Realtor, Dies

NEW YORK, N. Y.—Lemuel E. Graves, retired New York realtor, died here Friday night at age 74. He had been ill for about two months and had been hospitalized at the Neurological Institute of the New York Medical Center and at Francis DeLafayette Hospital since he was stricken.

He was buried Sunday in Frederick Douglas Cemetery in New York following services at St. Phillips Church here.

Born in Raleigh, N. C., Mr. Graves graduated from Shaw University in Raleigh and from Cornell University in Ithaca, N.

Y. He taught at Talladega College in Alabama and at Florida A. & M. College in Tallahassee, Fla., prior to World War I. He served with the YMCA service during the war.

After World War I, Mr. Graves entered the insurance business serving with the Standard Life Insurance Company of Atlanta, Ga., and later founding the Eagle Life Insurance Company of Raleigh, N. C.

He came to New York 25 years ago and later establish-

A long-delayed school integration school integration suit entered its final stages last week with a federal judge noting that "we may well face this now." The Pupil Assignment Law is now...

With those words Judge Edwin M. Stanley ruled that whatever pattern of segregation there may be in North Carolina has nothing to do with admitting two Durham Negroes to a white school.

The suit was brought by two mothers who sought to have their daughters admitted to a white school and, at the same time, to strike down racial barriers in public schools across the state.

Mitchell Sees Strong Rights Bill

RICHMOND, Va. — A Washington, D. C. NAACP official predicted Sunday a strong anti-integration stand by the Virginia General Assembly would prompt congress to enact stronger civil rights laws.

"I hope you folks here in Virginia can keep the state legislature in session... while congress is in session," Clarence Mitchell, director of the NAACP's Washington office, said.

The assembly convened Monday to enact a new anti-integration program.

"If they come up with some obstructionist plan for abolishing the school system," he said, "I'm sure we'll get the strongest civil rights laws yet."

Vicious Beating Fatal For Wake Woman; Mate Jailed

WAKE FOREST — Wilbur Wilkerson, 37, of Wake Forest, Route 1, telephoned the local police department Thursday night to report that he had just beaten his wife-to-death. He gave himself up when officers arrived at his home.

Mrs. Annie Mae Wilkerson's body was found bloody and bruised. She was 39, Wake Corner Marshall W. Bennett determined that head injuries had caused her death.

Deputy Sheriff Melvin Mann, who headed up the investigation, said that a broom had

been found at the house Friday morning. But he said Wilkerson probably used some other instrument in the killing.

The police department received the call about 2:30 a. m. The caller and his wife were probably drinking, it was theorized.

Officers have not been able to determine just what led Wilkerson to attack his wife. Investigation was continuing. Another man is believed to have been courting Mrs. Wilkerson.
