# **Six Were Charged In** Lane Rape

CHATTANOOGA, Tenn .-- Four of six youths acused of raping a white girl in a secluded "Lover's Lane" were sentenced Friday night o die in the electric chair.

An all-male criminal court jury deliberated three hours after a day-long trial. Under Tennessee law a jury may pass sentence.

Attorneys for the four youths immediately filed notice of appeal. Two other boys, James Wood, 17, and Freddie Williams, 19, were held separately and will be tried later on the same charge.

The victim, a 17-year-old native of Twenty-Nine Palms. Calif., was visiting relatives when the alleged attack occurred. She said she and a male companion had parked in the secluded spot when the youths appeared, forced the couple from the car and took


#### Honor Society Installed At Ligon School




