Dr. Miller, who will assume office on September I, is an associate professor of biochemistry at Meherry Medical College and a former professor of chemistry at the Agricultural and Technical College of North Carolina. He is also a Council Member, Oak Ridge Institute of Nuclear Studies, and has served as a research scientist at the Institute.

terson declared: "We are convinced that the appointment of this distinguished nuclear scientist and experienced teacher will enhance educational standards at Bennett College and contribute to the further acquisition of a highly qualified facul-

"For the first time in the college's 93-year history," Dr. Patterson added, "Bennett faculty members worked closely with the institution's governing board in establishing criteria for the selection of a new president.
