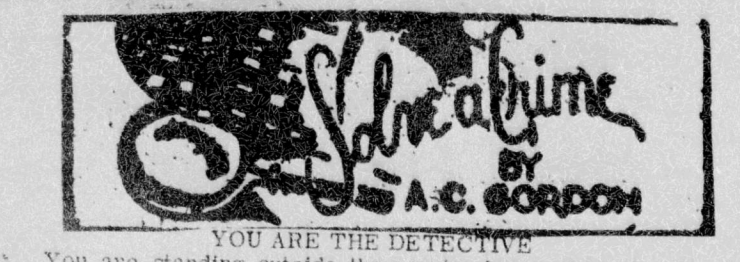
**Smithfield News**
