


## Fuguay-Varina News

COLLEGES ON WAY OUT NEW ORLEANS - (NPI) -

What seems to be the death of segregated colleges and universities in Louisiana appeared last week when the presidents' council, Louisiana State

Board of Education, ordered

desegregation plans to be draft ed for all 10 state institutions of higher learning.

The council has scheduled a meeting to determine what the schools must do in the light of court orders to desegregate their respective student bodies and faculties.

Four sections of the state will be most concerned-New Orleans, Ruston, Baton Rouge and Shreveport. These are where jim crow colleges and universities exist as a means of keeping Blacks out of white institutions.

If indications are correct, this could mean the death of the Black institutions and merger with white schools. The mergers would be seen as occurring between Southern university, Baton Rouge and Louisiana State university; Southern university, New Orleans, and LSUNO; Southern university, Shreveport, and LSU; and Grambling college and the state school in Ruston.

The schools have until May 20 to submit plans. If they fail . to come up with a suitable plan by then, the Health, Education and Welfare department will give them a plan. This may mean a loss of millions of dollars in federal funds, if the state cannot provide a plan acceptable to the federal government.

The Black institutions are not in the least comparable with those which were and mostly still are white schools, both in facilities and services.
