Diggs Protests Stops U. S. Ads By African Airways

WASHINGTON, D. C. - In May of this year, Congressman Charlie C. Diggs, Jr., (D-Michigan) demanded that the, Civil Aeronautics Board show cause why South African Airways should not be prevented from engaging in deceptive advertising. These ads, designed to promote travel to South African, referred to activities and accomodations which were not available to visitors on a non-discriminationial basis.

THE ER PU STARTED OUT IN ANCIENT

It was the Congressman's view that where South African Airways advertises facilities in South Africa it should at the same time inform the public that said facilities are not equally available to all tourists, white or non-white.

The Civil Aeronautics Board's Bureau of enforcement has agreed in a letter to the Congreeman today that in the absence of such a statement these advertisements are misleading. South African Airways has, therefore, been ordered to cease and desist from the distribution of brochures and other promotional materials which refer to facilities not available to persons of all races. Diggs, in hailing this historic order, said it is analogous to the caution that "cigarette smoking may be hazardous to your health,"
