
and four plays later Wolfrum again scored from the two-yard line. Stevenson kicked the extra point. The scoring in the second

quarter was started by a 38vard field goal by Stevenson. Later in that quarter, Randy







The report emphasized that, as more blacks and browns have moved into the central cities, more whites are leaving for the suburbs. Those in the contral cities face severe unemployment, turbulent schools, poor housing, and

high crime rates. The co-chairmen of the Commission were Mayor John V. Lindsay of New York and Senator Fred R. Harris of Oklahoma.
