





ACTION seeks to have Northwest changed to Angela Davis High School; Soldan to Robert Curtis High; Beaumont to Malcolm X High; and Central to Dr. Martin Luther King High. It is said approximately twenty-five thousand leaflets entitled "2 Days Off -- Robert Curtis - Angela Davis Days" and having pictures of Attorney Robert Curtis, a former controversial St. Louis Legal Aia lawyer, now with a Legal Aid Project in Newark, New Jerbeen circulated.




